One Lot Drainage Review for Residential or Commercial	\$200
Drainage Reports and Documents (Two or more lots)	\$300
Resubmittal Fee for Storm Drainage Plan & Reports Review	\$50
Minor Subdivision PWDN Review	\$400
Major Subdivision PWDN Review	\$500
FEMA LOMRs, LOMAs, & LOMCs	\$500
Storm Water Pollution Protection Plan (SWPPP): Up to two acres	\$300
SWPPP Fee (every acre above two acres)	\$50
PERMITS (AR2015-68)	
Grading, Project Civil Infrastructure Costs less than or equal to \$100,000 (per day up to a maximum charge for five days)	\$50
Grading, Project Civil Infrastructure Costs greater than \$100,000 (per day, for the first five day, plus \$25 per day, every day thereafter)	\$50
Paving Permit (per day, no limit)	\$50

ACCESS, DRIVEWAYS, CURB CUTS, SIDEWALKS (AR2015-69)	
Drivepad/Driveway Access (each)	\$120
Curb Cut Permit (each)	\$120
Sidewalk Permit	\$80 + \$0.30 per FT in excess of 100 FT
Curb & Gutter Permit	\$80 + \$0.30 per FT in excess of 100 FT
Valley Gutter Permit	\$0.50/SF (typical 240 SF)
EXCAVATION (AR2015-69)	
Excavation Administration & Inspection Fee, a separate permit required for every 660 FT (PWEF)	\$40.00/day (no limit)
Street Surface Restoration Fund Fee - Non-Paved Street	\$100
Street Surface Restoration Fund Fee - Paved Street less than three years old	\$150.00 + \$10/SY

TRAFFIC BARRICADING (AR2015-70)	
Barricading Application Fee, Resubmittals result in an additional \$30 fee (TRBA)	\$30.00
Non-County Sponsored Projects: LANE CLOSURE	\$0.045/SF/day for area of infrastructure occupied by construction work zone. Work zone area will be computed utilizing the taper length formula in MUTCD. Minimum work zone length is 50 FT and minimum lane width is 10 FT. Work zone area will be computed in 50 FT increments.
Non-County Sponsored Projects: DOUBLE LANE CLOSURE on Arterial or Collector Roads	200% of Single Lane Closure Fee
Non-County Sponsored Projects: ROAD CLOSURE or Double Lane Closure on Arterials or Collectors	200% of Single Lane Closure Fee
Non-County Sponsored Projects: SHOULDER WORK	1/3 of Single Lane Closure Fee
Barricading Fee for County Sponsored Projects	1.5% construction costs for projects equal or less than \$750,000 and 1.0% for construction costs greater than \$750,000
